#### 7.0 OLD BUSINESS

#### 7.1 HMIS/BFZ Updates

G Zinck reported that the By-Name is growing, currently at 78 names with 15 being veterans.

Veteran numbers might be off so BFZ is assisting to correct this in HMIS. Live training for BFZ on May 11/12.

H Mach pointed out that HMIS responsibility is now with Joe Davis; annual training will be announced today.

#### 7.2 ESG Post Funding

B Kyker stated the State will send out the announcements of funding and the packets to complete.

#### 7.3 DHS Grant

Prairie State Legal Services and Consumer Credit are splitting the DHS grant.

#### 7.4 Winter Overnight Homeless Shelter

B Kyker stated we're looking at being more proactive next year for being prepared for cold weather crises. There will be a conversation about how it has been handled as a way to improve preparation for next year. Pioneer hotel program will continue, as there are dedicated funds for emergency motel stays during extreme weather events like polar vortex. Interested CoC members can attend Housing and Services Committee to discuss this.

#### 7.5 PIT Count

S Tenuto stated Pioneer is grateful for the collaboration and will meet in the fall to discuss further. Empower Shower was a good opportunity for PIT. Reminder to let G Zinck know what beds are available currently. H Mach stated the housing inventory count number is very important for the CoC reporting. H Mach also stated that 11 is a high number of unsheltered for the county (we normally identify 1-2), and we assume the Empower Shower is the reason we were able to identify them. G Zinck pointed out that the lack of housing inventory is also contributing. 29 names at this time with no PSH beds available.



#### 8.0 NEW BUSINESS

#### 8.1 Continuum of Care Strategic Plan

K Violett pointed out our **goals** in the **CoC's Strategic Plan** on **page 19** and that all committees should be using this page to guide us. We will discuss this more frequently to keep this in mind; it goes through 2023. It is good to look at the County's Strategic Plan also. The County Board is more in tune with the CoC at this time, which is a positive.

#### 8.2 Chair of Community Awareness Committee

K Violett acknowledged that B Kyker has stepped into the Chair role following J Davis needing to step down. L Franz made a motion to formally appoint B Kyker to the Chair role seconded by J Menzer, and a voice vote was held as follows, resulting in the motion carrying:

#### 8.3 Rental Assistance Program

H Mach stated the data is being massaged and entered without negatively impacting the



CoC. Congress may approve a similar program at a lower level. The program is now closed to new applicants due to the money being exhausted. Various agencies worked together to administer the program. K Ulbrich stated the 100 per month recertifications are challenging to complete. 780 families/households have been served through this program.

#### 8.4 New Affordable Housing ~ HOME/APR funds

B Kyker stated the Taylor Place Apartments are being added to our inventory (54); they should be prepared for move-in in 2 years, 30% AMI. Pearl Street Commons II is also being planned, for 2025 ~ 28 additional units. Watch for email updates from Community Development. K Violett commented on the current gap between what people can afford vs what places are renting for.

#### 8.5 CoC June Meeting Dates

2 dates needing to be moved due to lack of meeting spaces: June 8 for Steering Council and full CoC Board June 22. Motion made by L Heneks and seconded by J Dorfner to move the dates accordingly; all were in favor and motion carried.

#### 9.0 **OPEN FORUM –** Agency Conversations, Success Stories

J Menzer stated there is a local motel that closed so there are hygiene items available. Senior living places might find these to be useful.

H Mach stated tomorrow the Senior Services Grant Commission will meet and the application process will begin; A zei will keep us informed. All grant agreements will generally start 7.1 but will move to 10.1.

#### 7.0 OLD BUSINESS

#### 7.1 HMIS/BFZ Updates

G Zinck reported HMIS training was held. Reporting is being changed.

Coordinated Entry ~ one Scattered Site opening occurred, and an individual is slotted to move in (first in months). By-name List is still operational, and data seems to have been 100% last month. Built for Zero meeting focused on veterans occurred and was attended by various members of our CoC. Lovell FHC is adding in their referrals for McHenry County which will help the By-Name List. G Zinck sent out the Inventory page and asked for edits.

#### 7.2 CoC Competition Results

B Kyker reported 126.5 out of 176 points. There is very little feedback provided on the scoring from HUD. We will go into the next competition losing 10 points, unfortunately, due to lack of RRH inventory. We scored highest on COVID response. Overall disappointment with our score. We will do what we can to increase our score. Inner collaborations is an area to focus on this year.

#### 7.3 Final PIT Count Results Report

Thanks to S Tenuto for leadership on this. Report was included in meeting package. H Mach stated we seem to have had an increase in the number of unsheltered people (11 up from 1-2) and the reason is the Empower Shower which draws homeless people out (this event is new this year). The 11 individuals are primarily made up of individuals who are choosing to live unsheltered in their cars/tents and service providers are still attempting to provide services.

W Corps commented that there are more than 11 unhoused individuals as per reports from clients and W Corps is doing their best to reach out.

#### 7.4 Rental and Mortgage Assistance Update

B Kyker stated McEURAP is now closed with a few exceptions. K Ulrich reported the Housing Authority is working through recertification backlogs.



#### 8.0 NEW BUSINESS

#### 8.1 Emergency Solutions Grant Funding Packet

B Kyker stated he has filled out the CoC packet and the packet for individual agencies will be sent in the next week.

#### 8.2 Youth Homelessness Demonstration Program NOFO

B Kyker stated HUD opened this to 25 communities only. The application includes the need for a committee that includes someone with lived experience. He brought it up in the event an agency intends to apply. S Tenuto stated PC has 2 programs for this population of young adults experiencing homelessness.

#### 8.3 HOME/ARP Public Meetings

B Kyker said these were held over the past week and they went well. There was one public comment related to wait lists.

#### **8.4** McHenry Coc – Housing Snapshot Report

G Zinck reported on the county housing capacity, which changes day by day. K Violett asked us to double check the report for our agencies, as the Housing and Services Committee will make use of this report. This will help us understand the needs better.

H Mach indicated that this report relates to the overall scoring for the county and for the competitions.

#### 9.0 OPEN FORUM - Agency Conversations, Success Stories

- Community Coordinated Child Care is open and operating again. There is a shortage of childcare.
- J Dorfner with VAC announced she is retiring June 3.
- Senior Services Grant is open.
- S Rose stated her mother had experience with the ER and the ER was packed with COVID patients – it is on the rise.
- V Peschke announced the Woodstock Food Pantry has had generous donations and access can happen 2x/month.
- B Meath indicated the finance committee needs more members since we are going to the UFA as a CoC.
- B Kyker said the CoC website has been going well. 10-12 individuals have reached out and one nonprofit agency.

- 4.1 Homelessness Awareness Month Community Engagement / People in Need Forum

  - The committee discussed Neighbors In Need and whether or not the name is too broad. The idea of adding a subtitle like "Understanding Homelessness in McHenry County" is praised.
  - Nancy brought up font size and design possibilities for the Neighbors In Need signage.

- Brandon mentioned that 2-3 bands have expressed interest in performing at the event but no time slots have been discussed yet.
- Brandon has not talked to any food trucks yet but has started thinking about what kind of food options they might need.
- Nancy mentioned food trucks are very specific with the amount of food they bring and sometimes can run out of food.

- Megan reminded the committee of the importance of having soft foods available for homeless who may have poor dental hygiene or are missing teeth.
- The committee discussed the idea of providing chips and drinks to offset the costs of the food trucks.

- Sam and Nancy both mentioned promoting the website and keeping it updated.
- Nancy discussed how people can suggest a post for the website and allow other people to write blog posts.
- Julie brought up the idea of bringing in an intern to work on the website.

#### **Client Stories - Examples**

#### Story #1

Former client arrived at PADS in December of 2019, after being kicked out of their home with nowhere to turn. Client was 19 years old and had no idea what they were doing. Client had been diagnosed with depression, anxiety, and struggled with alcohol and substance abuse. Client was at PADS for almost ten months due to COVID shutting everything down, and during their time at PADS they accomplished so much! They grew as a person, were able to work on and maintain sobriety, rebuilt relationships with family members while creating new relationships with peers, transitioned into an independent living facility, and agreed to begin therapeutic services. Client opened up to staff about themselves, their past, and their relationships and became comfortable around PADS, so much as to even show new clients the ways of the shelter. Client and I worked together on setting realistic goals and figuring out the steps needed to achieve them. Client struggled here and there but was able to work hard and achieve each of their goals by the time they left PADS.

Personally, I cannot imagine where this client would be without PADS or without having someone taking the time to listen to this client. This client was a bright, thoughtful, creative, and nice individual, who would go out of their way to help others before worrying about themselves.

About seven months after them leaving PADS, I was shopping at Walmart and ran into this former client and they were excited to tell me that they were still working on certain goals and was doing well! I was overjoyed to hear this and wished them the best!

Tari called of the 1st of December, living in her car for a year and afraid it was going to be repossessed. Three appointments for intake later, she finally arrived on December 9th. Tari's face was chapped from the cold and her car piled high past the windows with her life for the last year. Anxious and apprehensive, she came in and made her bed. It took a few days of sitting and watching before she was ready to shower. A few more days and Tari's routine took shape; where she sat for breakfast, selfcare and sleep.

After two weeks of meeting with her case manager, Tari was able to confess the depression that weighed on her and eventually was the cause of her homelessness. She continued forward with the help of case management, surprised at the resources available to her, and revisited previous medications. Tari was as gentle and sweet as she was quiet. The children at the shelter quickly took to Tari and her to them. She continued developing relationships at the shelter. By Christmas, we would see Tari assisting other clients in decorating the Day Room and smiling.

Tari continued moving forward in the new year, obtaining an ID and applying for medical assistance/insurance. In early February, Tari developed a plan for continuing her medications and beginning therapy.

Early March, Tari was given an opportunity to move into an independent group home in Pioneer Center's Behavioral Health Residential program. As she was taking this next step forward, Tari expressed she was nervous, but grateful. As she was leaving on the next step in her journey, Tari hugged each of us, smiling and said, "I'm so happy I came to PADS." Tari is still thriving, independently.
