L Heneks stated that Home of the Sparrow is in the process of hiring someone to oversee the Landlord Engagement and Assistance program.

The committee continued to discuss possible incentives and what the spend down of incentives have been for Home of the Sparrow. K Miller spoke to what the State's RRH program incentive eligibilities are. K Miller said that a vast majority of the incentives have been nonrefundable signing bonuses for landlords. B Kyker said he would review other grants to see where incentives would be eligible. K Miller spoke about Home of the Sparrow applying to the Community Foundation for their Transformational Grant.
